In ones private capacity, for each harassing letter, or visit received thus after acceptance of this Lawful notice, until writ has been completely satisfied, and addressed in a court of records. Any attempt to enforce color of authority, by use of sheriff/police force will be met with charges of United States Codes: Rico Acts Title 18, RACKETEERING, EXTORTION, and FRAUD, as well as forced obligation without proof of authority, against sheriff/police and all parties listed in this writ, (all parties to the matter must provide written and verifiable numbers of delegation of Authority order from Congress) Forced obligation without contract, denotes (slavery). Any and all fees and fines wrongful placed upon I/me, Zilliah S. El (free national name) after this lawful notice and Contract Rescission will be perceived as a disingenuous attempt to extract revenues and or property from a natural person. : Though absolutely no contracts exist, or have ever existed! I will work diligently to remove bonds of all government officials involved in the unlawful removal of me and or property or both, as I object to any colorable proceedings and denial of due process in law. I am not a 14th and or 15th amendment citizen, being only granted privileges. I am a natural person with whom has a nationality proclaimed for the public record, and I command that all government officials secure my preexisting constitutional republic rights of the Federal Republics Organic Constitution of North America, as well as the Organic Connecticut Republic.

- 1. The term "extortion" means the obtaining of property from another, with his consent, induced by wrongful use of actual or threatened force, violence, or fear, or under color of official right.
- 2. The term "racketeering" means the extortion of money or advantage by threat or force, and or a pattern of illegal activity (as extortion and murder) that is carried out in furtherance of an enterprise (as a criminal syndicate) which is owned or controlled by those engaged in such activity.

If you or your organizations wish to place any further obligations upon I/me, especially thus after this contractual rescission, though absolutely no contracts exist, or have ever existed! of any, and all unilateral adhesion contracts, I demand that first you show proof of authority.

- 2. When does such authority expire?

- 3. Is your *corporation*, foreign or nomeous.
 4. Are you able to address to me, verifiable incorporation papers?
 4. United States Republic Constitution all 5. At which point does the United States Republic Constitution allow private corporations to impose obligations upon natural persons? (This denotes Slavery)
- 6. What is the nationality as well as political allegiance of Steven King and Barbara King?
- 7. Are both Steven King as well as Barbara King, claimants to authority able to show proof of nationality, as well as verifiable certificate of status?

For the record, I repeat, I have absolutely no unilateral adhesion contracts between any private fictitious corporations, or representative of such parties, wishing to abridge my liberties, protected under the United States Republic Constitution of North America. Any corporations of claimants to authority unable to provide proof of such claim will be sued in his/her own private capacity for violation of Constitutional Republic rights. Title 18 racketeering, extortion, fraud, burglary, theft as well as forced obligations (slavery), and if detained or arrested, kidnapping. I demand all organizations and claimants to authority to respond honorably. This Writ is my honorable and 'Good Faith' attempt to clear up any insensate misrepresentations or confusion, concerning resolutions in this matter, before taking any further actions. FOR THE RECORD. A failure of your companies and claimants to authority (the fore-mentioned Entity or Representatives) to 'Respond' to this lawful request within the allotted five (5) days of Receipt of this 'Writ in the Nature of Discovery, Notice of Status Change, Contract Rescission, though absolutely no contracts exist, or have ever existed! Bill of Particulars, and Fee Schedule, Declaration of National Status, Birthrights, and Free National Name' will be considered as an affirmation of disingenuous intent, and the said failure of Response to the twelve (12) above - noted issues, will be deemed a 'Dishonor' of this 'Notice and Demand for Disclosure'. Judicial Notice and Proclamation

To All Elected United States Republic Officials and Public Servants of Federal, State, City, and Municipal Governments, Personnel and Corporate Entities: Concerning the Constitution and all Statutory and Civil Law Codes of the Land, etc.,

Know All Men by These Presents:

Upon my inherited Nobility, and upon my Private Aboriginal / Indigenous, Proper Person Status and Commercial Liability, **I, Zilliah S. El,** being duly Affirmed under Consanguine Unity; **pledge my National, Political, and Spiritual Allegiance to my Moabite / Moorish Nation** - being the archaic Aboriginals / Indigenes of Amexem (the Americas); standing squarely affirmed upon my Oath to the 'Five Points of Light' - Love, Truth, Peace, Freedom, and Justice; do squarely Affirm to tell the truth, the whole truth, and nothing but the truth; and having knowledge and firmly - established belief upon the historical, lawful, and adjudicated Facts contained herein.

<u>United States Republic Constitution, Article I of the Bill of Rights</u> - Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances.

"Citizenship is a political tie; allegiance is a territorial tenure. [...] The doctrine is, that allegiance cannot be due to two sovereigns; and taking an oath of allegiance to a new, is the strongest evidence of withdrawing allegiance from a previous, sovereign" Talbot v Janson, 3 U.S. 133 (1795)

I affirm my residence, domicile, state are within myself as I can not reside, domicile, or have an address outside of myself. As noted above I voluntarily with full understanding, knowingly pledge my National, Political, and Spiritual Allegiance to my Moabite / Moorish Nation.

<u>States</u>. A people permanently occupying a fixed territory bound together by common-law, habit and custom into one body politic exercising, through the medium of an organized government, independent sovereignty and control over all persons and things within its boundaries, capable of making war and peace and of entering into international relations with other communities of the globe. Unites States v. Kusche, d.C. Cal., 56 F.Supp. 201 207, 208.

"Just as there is freedom to speak, to associate, and to believe, so also there is freedom not to speak, associate, or believe. "The right to speak and the right to refrain from speaking are complementary components of the broader concept of individual freedom of mind." Wooley v. Maynard, [430 U.S. 703] (1977). Freedom of conscience dictates that no individual may be forced to espouse ideological causes with which he disagrees:

"[A]t the heart of the First Article of the Bill of Rights is the notion that the individual should be free to believe as he will, and that in a free society one's benefits should be shaped by his mind and by his conscience rather than coerced by the State." Abood v. Detroit Board of Education [431 U.S. 209] (1977)

"Freedom from compelled association is a vital component of freedom of expression. Indeed, freedom from compelled association illustrates the significance of the liberty or personal autonomy model of the First Article of the Bill of Rights. As a general constitutional principle, it is for the individual and nt for the state to choose one's associations and to define the persona which he holds out to the world." [First Amendment Law, Barron-Dienes, West Publishing, ISBN 0-314-22677-X, pp. 266-267]

Being competent, In Propria Persona (In My Own Proper Person), to Attest to this Affidavit upon which I place my Seal/Signature; Whereas, I State, Proclaim, and Declare the following to be true, correct, certain, complete, not misleading, supreme, and not intended to be presented for any misrepresented, 'colored' or improper use or purpose, to wit:

That I, **Zilliah S. El**, Am a Noble of the Al Moroccan Empire (North America) In Propria Persona (my own proper self); being Moorish American - a Descendant of the Ancient Moabites / Moors, by Birthright, Freehold, Primogeniture and Inheritance; being Aboriginal and Indigenous to the Land /s (Amexem / Americas) Territorium of my Ancient Moabite / Moorish Fore-Mothers and Fore-Fathers - to wit:

The Al Moroccan (American) Continents - are the Land of the Moors; being North America, South America; Central America; including the adjoining Islands (Americana / Ameru / Al Moroc). I have, acknowledge, claim and possess, by said Inheritance and Primogeniture, the Freehold Status thereto; all Unalienable and Substantive Rights, to Be, to Enjoy, and to Act, distinct in my Aboriginal Customs and Culture; and determining my own political, social, and economic status of the State. Turning my heart and mind back to my Ancient Mothers and Fathers - Moors / Muurs, by Divine and Natural Right. Being Moorish American, we have and possess the internationally recognized Rights to determine our own 'Status of the State' absent of threat, coercion, or acquiescence to a Color-of-Law, a Color-of-Office, nor to be subjected to an imposed Color-of-Authority.

I, Zilliah S. El, can never at any time ever be a member/citizen of the union states or the United States of America as established via the United States Republic Constitution Article I, Section VIII, Clause XVII which is also affirmed in the Original 13th Article of the Bill of Rights, Section 12 of 20, in that it states:

Section 12: The traffic in slaves with African is hereby forever prohibited on pain of death and the forfeiture of all the rights and property of persons engaged therein; <u>and the descendants of Africans shall not be citizens.</u>

All those of European ancestry are foreign to all Moorish Americans. Therefore all Europeans and European Jurisdiction are a Foreign Jurisdiction to Moorish Americans as affirmed in the United States Republic Constitution:

The United States Republic Constitution Article I, Section X, Clause I: No State shall enter into any Treaty, Alliance, or Confederation; grant Letters of Marque and Reprisal; coin Money; emit Bills of Credit; make any Thing but gold and silver Coin a Tender in Payment of Debts; pass any Bill of Attainder, ex post facto law, or Law impairing the Obligation of Contracts, or grant any Title of Nobility.
